INTERNATIONAL SUMMER SCHOOL
MIGRATION LAW FROM EUROPEAN
AND INTERNATIONAL PERSPECTIVES

18 – 22 July 2011



Course Contents and Structure

Over the years migration flows have significantly affected not only the structure of the EU and national labour markets but also society as a whole. Understanding national and EU migration legislation, as well as the general framework provided by International Law and non-EU legal systems, has become essential to students' learning and lawyers' professional training.

The International Summer School is a high quality and intensive academic program organized by the Law Faculty of the University of Brescia, open to students from around the world and to professionals. This year the course will offer the opportunity to explore the European and International Migration Law and compare the refugee and asylum policies of the European Union and the United States.

The program will provide a theoretical and practical training on the topics, focusing on some selected issues, including the following:

- √ EU Legal instruments governing migration;
- √ Protection of migrants' fundamental rights and access-to-justice procedures;
- √ External border control;
- √ Removal and repatriation policies;
- √ Legal conditions of refugees and asylum seekers in the EU;
- √ Comparative analysis of asylum system and protection of refugees in EU and US.

The course will take place from 18 to 22 July 2011. Classes will be held by leading academics, practitioners who are experts in the field and officials from the European Commission. The course will include lectures and workshops, including case studies and practical exercises. Lectures will take place in the morning and workshops in the early afternoon.

Language

Application deadline

30 June 2011 or later, subject to availability.

Certificate of Attendance, ECTS and Accreditation

A certificate of attendance is awarded at the end of the program and 3 ECTS (European Credit Transfer System) are recognized if at least the 85% of the classes have been attended. Non-European students can be granted credits under the conditions fixed by their home universities. The course is accredited by the Local Bar Association for the purpose of CPD (continuing professional development).

Course materials

The course material will be available on the website of the International Summer School before the beginning of the course. Students will be provided with a CD Rom including all the material at the end of the course.

Tuition Fee, Registration and Accommodation

There will be no tuition fee for students registered at a University or a Law School (including PhD and Master students). A tuition fee of 200,00 euros is required to other applicants.

A limited number of scholarships (covering accommodation and meals) is available for foreign candidates, accepted to the program and registered at a non-Italian university. The University can provide a list of accommodations at low rates for all applicants.

Transport and facilities

Information to help students travel to and from Brescia will be available on the website of the Summer School. For students coming from abroad (Europe) the most suitable option is flying to Orio al Serio Airport (Milan-Bergamo) or Valerio Catullo Airport (Verona). Low cost company fly to both airports, which are 45 minutes away by car from Brescia. Buses and coaches run between the airports and the town centre (close to the University and to the accommodations). For overseas students (US or other regions) the better solution is flying to Milano Malpensa Airport or Milano Linate Airport.
